The latest Commitment of Traders report from the New York arabica coffee market has seen the shorter term in nature Managed Money fund sector of this market decrease their net short sold position within the market by 11.71% over the week of trade leading up to Tuesday 2nd October; to register a new net short sold position of 93,148 Lots. Meanwhile the longer term in nature Index Fund sector of this market increased their net long position within the market by 0.0% to penister a net long position of 44.472.1 (as on the day.

Over the same week, the Non-Commercial Speculative sector of this market decreased their net short sold position within this market by 10.92%; to register a new net short sold position of 97.175 Lots. The latest Commitment of Traders report from the London robusta coffee market has seen the Speculative Managed Money sector of this market decrease their net short sold position within this market by 10,20% during the week of trade leading up to Tuesday 2nd October; to register a net short sold position of 31,442 Lots on the day. This net short sold position which is the equivalent of 5,240,333 bags has most likely been reduced further, following the period of positive trade, which has since followed.

The January 2019 to December 2018 contracts arbitrage between the London and New York markets widened, to register this at 34.74 usc/Lb., while this equates to 31.06% price discount for the London Robusta coffee market. The Certified washed Arabica coffee stocks held against the New York exchange were seen to decrease by 1,630 bags yesterday, to register these stocks at 2,410,406 bags. There was a decrease of 3,134 bags to the number of bags pending grading for this exchange; to register these pending grading stocks at 58,028 bags.
