## Coffee Market Report

The latest Commitment of Traders report from the New York arabica coffee market has seen the shorter term in nature Managed Money fund sector of this market decrease their net short sold position within the market by 6.61% over the week of trade leading up to Tuesday 30th. April; to register a new net short sold position of 73,304 Lots. Meanwhile the longer term in nature Index Fund sector of this market increased their net long position within the market by 1.1%, to register a net long position of 38,940 Lots on the day.

Over the same week, the Non-Commercial Speculative sector of this market decreased their net short sold position

Over the same week, the Non-Commercial Speculative sector of this market decreased their net short sold position within this market by 6.59%; to register a new net short sold position of 70,845 Lots. This net short-sold position which is the equivalent of 20,084,244 bags has most likely been increased again, following the period of overall more negative trade that has since followed and likewise, that of the Managed Money Fund sector of the market. It was a shocking day of trade within the coffee markets yesterday, with the markets coming under severe selling pressure and with the New York market setting new thirteen-year lows and the London market new nine-year lows. The prospects of a new large Brazil crop shortly to start impacting upon an already well stocked market, impacting upon the prevailing negative sentiment.

The July to July contracts arbitrage between the London and New York markets broadened yesterday, to register this at 29.26 usc/Lb., while this equates to 33.25% price discount for the London Robusta coffee market. The Certified washed Arabica coffee stocks held against the New York exchange were seen to remain unchanged yesterday; to register these stocks at 2,438,992 bags. There was meanwhile no change to the number of bags pending grading for this exchange; to register these pending grading stocks at 3,990 bags.

The Certified Robusta coffee stocks held against the London exchange were seen to increase by 3,667 bags or 0.19% over the week of trade leading up to Monday 6th. May, to see these stocks registered at 1,965,000 bags, on the day.
