## Coffee Market Report

The latest Commitment of Traders report from the New York arabica market has seen the Non-Commercial Speculative sector of this market decrease their net short sold position within this market by 15.04% over the week of trade leading up to Tuesday 5th. November; to register a new short sold position of 58,415 Lots. This net shortsold position which is the equivalent of 16,560,394 bags has most likely been marginally decreased, following the period of mixed but overall firmer trade that has since followed. The latest Commitment of Traders report from the London Robusta coffee market has seen the Speculative Managed Money Sector of this market decrease their net short sold position within the market by 6.23% over the

week of trade leading up to Tuesday 5th. November; to register a short-sold position of 50,457 Lots. This net short sold position which is the equivalent of 8,409,500 bags has most likely been little changed, following the period of mixed but overall firmer trade that has since followed.

The December to January contracts arbitrage between the New York and London markets broadened on Friday; to register this at 46.67 usc/Lb. This equates to 42.64% price discount for the London Robusta coffee market. The Certified washed Arabica coffee stocks held against the New York exchange were seen to decrease by 2,750 bags on Friday; to register these stocks at 2,224,337 bags, with 87.2% of these certified stocks being held in Europe at a total of 1,940,625 bags and the remaining 12.8% being held in the USA at a total of 283,712 bags. There was no change to the number of bags pending grade to this exchange, to register these pending grading stocks at 10,596 bags.
